National Beef Pathogen Quarterly Verification Testing

This letter is to convey the results of National Beef Packing's cloth sampling verification testing. In FSIS Notice 65-07, it is suggested that a best practice for producers of raw materials that will be utilized in raw, non-intact product perform a "verification" test. National Beef performs this "Verification Testing" under protocols described in "National Beef Process Assessment Testing" on a routine basis. The fundamentals of this program are that a "lot" that has been sampled under robust cloth sampling program and tested using an approved DNA test (Hygiena BAX) and found to be negative. This lot is then ground and sampled using robust protocols and is tested using an approved DNA Test (Hygiena BAX). Starting September 2012 National Beef added Non O157:H7 STEC testing to the testing process.
